Summary: The plaintiff had dental surgery performed by the defendant

Omura in 1983. She subsequently experienced various mental and physical health problems, which she alleged were caused by the negligence of the defendants, Omura and Kelly, her family physician. The defendants sought summary judgment on evidence, both on the basis that the claims against the

defendants were statute-barred under the applicable limitations legislation, and on the basis that there was no

evidence to support the allegations of negligence.

Issue: Should summary judgment be granted as against either or

both of the defendants, due to the limitation period of the lack

of evidence to support the negligence claim?

Result:

The court ordered summary judgment on the evidence in respect of both defendants. In each case there was evidence that the plaintiff had complained of deficiencies in her treatment in the 1980's or 1990's. The claims against both defendants were therefore statute-barred. In addition, the plaintiff provided no evidence – and, in particular, no expert evidence – that would support findings of negligence. As such, the claims had no real chance of success.
