Subject: Jurisdiction *Simpliciter* and *Forum Non Conveniens*.

Summary: The Petitioner brought separate actions pursuant to the *Divorce Act*, *Maintenance and Custody Act*, *Matrimonial Property Act* and a *Lis Pendens* action. The Respondent applied to stay all of those proceedings for lack of jurisdiction.

Issue: Whether the Court has jurisdiction and if so, whether it should defer its jurisdiction in favour of proceedings seeking similar relief in a Court in the State of Florida

Result: The outcome from this decision was time sensitive because the Court in Florida was scheduled to hear the case on its merits forthwith. A decision was rendered with reasons to follow to the effect that this Court has jurisdiction regarding all matters except those matters relating to the custody and parenting of the children and that it should exercise that jurisdiction even though the Court in Florida had already decided to accept jurisdiction over all of the issues. Reasons will follow in a separate decision.
