Issue: The Applicant seeks a Permanent Care Order with no provision for access

for the Respondents' infant daughter who was apprehended at birth. The Applicant relied upon the admission of s. 96, historical evidence from an earlier Permanent Care Hearing resulting in the Respondents' six year old twin daughters being placed in the permanent care of the Minister, with no provision for access. The Applicant further submitted that nothing had changed in the Respondents' lives since the issuance of the earlier

Permanent Care Order, and therefore the newly born infant child would be

at risk of harm if entrusted to the care of the Respondents.

The Respondents submitted that the dismissal of all sexual assault charges against the Respondent, J.W., was a change in circumstance since the issuance of the earlier Order which, thus, eliminated any concern regarding risk of harm and it was, therefore, safe to return their infant daughter to them.

Result:

The Court found that the infant child was in need of protective services, that the Respondents lacked total insight with regard to the parenting concerns of the Minister, and that there was no reasonable likelihood of change in the foreseeable future - Permanent Care Order granted with no provision for access.
